Default and repairing time: 30 mins after the scheduled start times.

Rate of play: All moves in 90 mins, plus 30 sec increment throughout.

Byes: Except for round 5, players may request one half point bye.

## Entry fees

Entry fee - all tournaments £39.

ECF members (silver and above) may deduct £9.

Juniors (U18 on 1<sup>st</sup> September 2020) may deduct £5 across all sections.

## Prizes

Prizes for each tournament: 1<sup>st</sup> £240, 2<sup>nd</sup> £140, 3<sup>rd</sup> £85

We give generous grading and slow starter (0/2) prizes according to the number of entries.

Ungraded players may not win grading prizes and not more than third prize in any tournament except the Open. Ungraded players must provide evidence of previous grades and recent performances in other competitions on a separate sheet.

In each tournament, the top player representing a club in the Torbay Chess League receives a cup. In addition a cup is awarded to the highest placed Devon player in the graded sections and to the highest placed Devon Junior.

A prize is awarded to the top team of 4 players from the same club. Team entries must be submitted before the end of round 2.
